WHERE WE SHOULD AIM

Because it is the safest and most reliable form of transportation, the railroad has a special responsibility to the public, and especially toward our regular patrons, when severe weather conditions develop. They expect us to keep going when things get rough. When we succeed, we make new friends and keep old ones happy. In other words, the extra effort put into keeping 'em rolling in snow, sleet and hurricane pays off.

This book spells out in detail the responsibilities of the employes of the New York Region in keeping the service as near normal as possible in times of severe storms and othe dislocations caused by weather conditions.

One of our most important responsibilities is to make sure that the public is informed as to what is happening. People on trains want to know, if they are delayed, how long they can expect to wait to get moving again. People in stations want accurate information, so they can make their plans. Shippers and receivers of freight want advice about the shipments they have entrusted to us. And the public in general wants to know how our service is performing.

Just as every employe is expected to carry out his assignment in the emergency, so also every employe in contact with the public has a duty to keep all the available information moving to them. On most occasions the severest criticism directed at the railroad is not that we may fail to maintain normal service in storm emergencies—the criticism is that in some instances we fail to let folks know what is going on, and their personal problems are severely complicated as a result. We can help ourselves and our railroad a great deal by correcting this situation.

In all that we do, of course, we must keep in mind that emergency situations represent enormous extra, unbudgeted costs. Preparedness and top efficiency not only gets things done faster, but also save money.

The booklets entitled "Informing Passengers and The Public" must be followed during periods of interruptions.

PREPARATORY

On or about October 15th:

REGIONAL ENGINEER:

Will:

Confer with Superintendent Equipment and see that all snow-fighting equipment is in proper condition and at proper locations for immediate use.

See that Track Supervisors have a sufficient supply of snow-fighting materials and tools at the proper locations.

See that Crossing Watchmen are provided with picks and brooms and a supply of rock salt for use in flangeways at Crossings and that they are instructed in their use.

See that Switch Tenders are provided with brooms.

See that snow fences are erected at proper locations.

See that switch heaters are properly installed and tested at locations where used.

See that a check is made with contractors and definite arrangements set up to have a specific number of men available for snow duty.

See that all snow-melting equipment is in proper condition and properly located.

SUPERINTENDENT EQUIPMENT:

Will:

Confer with Regional Engineer and see that all snow-fighting equipment is in good condition and available for immediate use.

See that adequate supply for DC Patrol Trains, such as-

Fusees Wood Shovels Track Brooms Jumpers Contact Shoes

are located and kept in stock at Newark Heating Plant.

See that portable third rail jumpers are available and in proper condition at locations specified in Special Instruction 1167-Bg.

See that adequate supply for AC Patrol Engines and trains such as—

Shovels
Fusees
Track Brooms
Pantograph Shoes
Rubber Gloves
Brake Shoe Keys
Ground Sticks

are at all terminals where AC electric trains or engines originate. Also see that an adequate supply of brooms is available at terminals where steam or diesel engines originate. See that a sufficient number of men are qualified for cleaning ice and snow from pantograph structure and roof under pantograph structure at all terminals where AC electric trains or engine originate, including yard engines in Sunnyside Yard.

See that adequate supply of solution of Glycerine and Flushing Oil is available for use on pantographs in sleet storms.

SUPERINTENDENT FREIGHT STATIONS

and

SUPERINTENDENT PASSENGER STATIONS:

Will see:

That stations are supplied with shovels, brooms and rock salt.

That an organization for disseminating information is provided and thoroughly instructed.

That Agents secure information and prepare lists showing names, addresses and telephone numbers of bus and taxicab companies in their territory that can be used in emergency.

That station facilities, such as heating, lighting, etc., are in proper condition.

OTHER DEPARTMENT HEADS:

Each department head will check the assignment of his forces to insure all concerned being thoroughly conversant with what is required of them in carrying out the Snow Program.

WHEN SNOW OR SLEET IS EXPECTED

When weather conditions indicate a snowfall or other condition that may interfere with normal movement of trains:

MOVEMENT DIRECTOR:

Will:

Notify Department Heads.

Receive all weather reports which will be furnished by (Supervising Operator) and advise proper officers of any unusual condition.

Check the location of snow plows, chloride and flanger cars to see that they are at proper locations and available for use, ordering chloride cars moved to a point where they will be under steam when requested by the Regional Engineer.

MASTER MECHANIC:

To arrange for painting of pantographs with solution of glycerine and slushing oil.

DEPARTMENT HEADS:

To arrange for the proper supervisory forces and equipment to be available as needed.

WHEN SNOW IS FALLING OR ICE FORMING ON CATENARY OR THIRD RAIL

DEPARTMENT HEADS:

To immediately assign their forces to proper locations to the extent necessary.

MANAGER PUBLIC RELATIONS:

Will keep currently posted on all movements affecting the public through the Passenger Manager's representative in "40" office. Will disseminate information to the public after such has been screened by Regional Manager's designated representative. Emphasis will be on what we are doing rather than on delays and annulments.

MOVEMENT DIRECTOR:

Train Dispatchers to obtain information at the first sign of snow or sleet and promptly notify Movement Director who will notify the Regional Manager and Department Heads, and at night, Sub-department Heads as shown on Page No. 23, as well as the Power Bureau at Philadelphia (Phone Broad 666.)

Will secure reports from engineman of any arcing and notify Regional Engineer and Master Mechanic.

When sleet is falling or ice forming on catenary, will on request of Regional Engineer issue instructions to electric engineman to operate with pantograph raised, as outlined in C. T. 290 and electrical operating instructions.

When sleet or snow is falling or ice forming on Third Rail, Movement Director, will order diesel engine to Hudson with compromise Car Coupler at both ends for use in assisting Hudson Tube trains in event of stalling.

Arrange on request of Regional Engineer for Patrol Trains, consisting of 5 or more MU cars or 2 electric engines coupled, to patrol affected territory.

Arrange to have snow screens applied on electric engines and MU Cars when so advised by the Power Bureau at Philadelphia.

Arrange for engines and crews for patrol trains, wire trains, and snow fighting equipment when requested by Regional Engineer.

As soon as third rail contact trouble is expected as advised by Regional Engineer, Movement Director will order crew from H. & M. R. R. Train Master at Hudson Terminal. Notify Power Director—UPtown 2021 or 2022, who will provide men to operate and accompany the Chloride Car.

REGIONAL ENGINEER:

Will:

See that an adequate force is maintained and that sufficient equipment is supplied to keep the road open.

Confer with the Movement Director and arrange for the operation of Patrol Trains and other Snow fighting equipment when conditions warrant, giving sufficient advance notice to Order Train and Engine Crews.

Advise the Movement Bureau and Train and Locomotive Dispatcher when the use of chloride cars is anticipated in order that the cars may be moved to proper location so that the solution may be properly heated.

Arrange for the operation of Chloride cars, flangers and snow plows when advice is received that trouble is being experienced.

Arrange to set up proper commissary arrangements for snow fighting forces.

Arrange for electric traction men at Trenton and Newark to inspect pantographs.

Arrange for electric traction men to accompany Patrol Trains and Patrol Engines.

Arrange for Electric Traction men to ride Hudson Tube Trains between Newark and Journal Square to keep informed on condition of Third Rail.

Arrange for Electric Traction men in Sunnyside Yard and at other strategic points as required by weather conditions.

Will advise Train and Locomotive Dispatcher of condition of wire requiring coupling of B-1 engines in Sunnyside Yard.

MASTER MECHANIC:

Will:

Assign a representative at Sunnyside Enginehouse to keep currently informed on all passenger road power and work directly with Road Foreman of Engines' representative in "40" office for power assignments. This person must be of a caliber that he can give reasonable estimates of power that will be available for several hours in advance. The same coverage must be provided at South Amboy and Meadows.

Arrange to protect operation at Bay Head with P. R. R. personnel to insure proper handling of P. R. R. equipment at that terminal.

See that sufficient force is available to prepare and turn engines without delay.

That all snow fighting equipment is so located and prepared that it can be dispatched promptly when ordered.

That Patrol Trains and Patrol Engines leaving terminals are furnished with necessary snow fighting equipment and qualified men to accompany equipment.

Keep in touch with all terminals to see that all needed supplies are available.

Be responsible for removing snow in shop and engine-house territory.

Provide qualified men at electric engine terminals and AC Multiple Unit terminals to keep cars heated and pantographs raised and clear of ice.

See that additional car inspectors are provided at Newark to keep doors operative on Hudson Tube cars.

See that additional fuses are placed on Hudson Tube cars.

Arrange for cleaning ice and snow from pantograph structure and roof under pantograph structure at all terminals where AC electric trains or engines originate, including yard engines in Sunnyside Yard.

Arrange to apply extra pressure on contact shoes and supply additional fuses on electric locomotives and cars.

Arrange to have heavier shoe and bus line fuses installed on Hudson Tube cars.

On request of T. & L. D. arrange for coupling of B-1 Locomotives in Sunnyside yard.

Adhere to Paragraph 4, Page 29, of the Sleet Instructions in C.T.290.

PASSENGER MANAGER:

Representative of Passenger Manager will locate in "40" Office, Room 258 (Ext. 2281). He shall keep clearly informed as to local transportation conditions, relaying the information obtained to office of Passenger Manager (Ext. 2056) so that it will be available to System Passenger Sales Department and other affected regions. He shall also furnish the Regional Transportation Department with such current information about regional static conditions as they may desire and information about conditions in other regions which may otherwise be unobtainable.

Passenger Manager's representative in "40" office shall keep Manager of Public Relations, Station Agents, Station Masters, Baggage Agents, the Superintendent Passenger Stations, and the Superintendent Freight Stations, furnished with such current information as is available in order that proper signs may be prepared, announcements made, bulletin boards kept currently correct as to conditions and fully informed as to probable delays and other unavoidable abnormalities of service and fully instructed as to what information they are to give passengers.

Station forces shall cooperate with the Transportation Department in relaying information to train crews vital to the

success of keeping the public informed.

It will be the duty of the Passenger Manager or his representative to see that the P.U.C. of N. J. receives prompt notification of any troubles being experienced and the steps being taken to meet the emergency.

SUPERINTENDENT FREIGHT STATIONS

and

SUPERINTENDENT PASSENGER STATIONS:

Will:

See that station forces are properly placed and prepared to meet any emergency situation that may develop.

Arrange for Trucking Service to furnish Trucks for

snow fighting service.

Arrange for Tractor Sweepers and Truck Plows as re-

quested by the Regional Engineer.

Public will be kept currently advised of train departures and schedules by appropriate signs and announcements.

SUPERVISORS OF TRACK:

Will:

Remain on their sub-divisions to see that forces are

properly assigned.

Confer frequently with the Ass't. Regional Engineer as to conditions as well as force and equipment needed to keep the road open.

Supply necessary food to all men employed on their sub-division at as convenient a location as possible.

See that sufficient force is assigned to clean crossings where the normal force is inadequate to keep snow and ice removed from crossings.

See that a sufficient supply of salt, snow melting oils, shovels, brooms and other equipment is distributed as required.

SUPERVISOR—COMMUNICATION & SIGNALS:

Will:

Confer with the Ass't. Regional Engineer to insure that adequate emergency forces are available to maintain the electric traction and communication lines and the operation of interlocking and signal systems.

Provide electric traction men on the platforms at Trenton and Newark to inspect pantographs.

Provide electric traction men to ride trains to keep in touch with weather conditions.

Provide electric traction men to ride Patrol Trains and Patrol Engines.

Provide electric traction men to keep third rail clear of snow.

Provide electric traction men in Sunnyside Yard and at other strategic points as required by weather conditions.

New York D. C. Electrified Zone, Chloride Car:—W. A. Potter, Foreman Third Rail, Residence—114-54 223rd St., St. Albans, L. I., Night Call—Laurelton 5-2340, Day Call UPtown 2409, will have charge of equipment of chloride car No. 497105, located on Supervisor's Material Track in Sunnyside Yard, and be responsible for its condition. The car is to be ready for service at all times and sufficient chloride is to be provided for 48 hours constant use. When third rail contact trouble is expected, he will provide Chloride Car with force.

Multiple Unit Chloride Train:—F. W. Sanders, Gang Foreman, Third Rail, Residence—6 Judith Place, Fords, N. J. Day Call UPtown 2379, Night Call Valley 6-3445 will have charge of the equipment of Chloride Car No. 497106 and the two MP-38 coaches located on No. 12 Track at Jersey City Passenger Station, and be responsible for their condition. The cars are to be ready for service at all times and sufficient chloride is to be provided for 48 hours constant use. When Third Rail contact trouble is expected he will provide Chloride Car with force.

Third rail men shall observe conditions and keep Power Director advised.

Request Train and Locomotive Dispatchers, New York (UPtown 2281) to have Multiple Unit equipment with pantographs having a minimum height of 25 feet 11 inches, or AC Motor with P-70 type equipment, operated on Trains 2500 and 2509, when the condition of catenary between Midway and SA justifies.

SUPERVISOR TRAIN MOVEMENT:

Will confer with Supervising Operator, Regional Engineer, Master Mechanic and Road Foreman of Engines in reference to train movements and to engines and crews for snow fighting service and necessary replacements for regular service. Will work with Freight Train Master and his organization in planning freight movements and work train service.

SUPERVISING OPERATOR:

Will be in charge of road train movement conferring with Train Masters, Supvr. Train Movement and Supvr. Passenger Train Operations.

Will locate at headquarters. Will have general charge of road train movement, collaborating with various officers for a coordinated operation. Will see that dispatchers office and towers are properly manned. Will cooperate in seeing that transmission of necessary information to stations is properly handled. Operators or levermen will be expected to operate switches during snow storms as little as possible and during sleet storms as frequently as possible, working in conjunction with M. W. employes.

PASSENGER TRAIN MASTER:

Will locate at headquarters. Set up his organization to cover all passenger train operation details, including substituted bus service. Will confer with Passenger Manager and System Superintendent Passenger Operation in planning his operation. Will arrange to see that the traveling public is properly informed where service is disrupted. Will arrange to cooperate in the care for the comfort of passengers unduly delayed.

SUPERVISOR PASSENGER TRAIN OPERATION:

Will have charge of passenger train movements in the New York Station and Sunnyside, conferring with Passenger Train Master, Road Foreman, Supervising Operator, Master Mechanic and Assistant Regional Engineer in planning train movements.

FREIGHT TRAIN MASTER:

Will have general charge of all yard transportation activities and confer with Supervisor Train Movement, Road Foreman, Master Mechanic, Assistant Regional Engineer and others, in planning yard and road train movements.

ROAD FOREMAN OF ENGINES:

Will:

Assign representative to handle all passenger power assignments and work directly with Enginehouse Foreman, Sunnyside, South Amboy and Meadows, The Power Coordinator, Philadelphia and Passenger Train Master in "40" Office.

Arrange to have pantographs lowered and raised frequently on electric engines and Multiple Unit cars when in charge of engine crews on siding or standing at any point, to prevent accumulation of sleet.

Arrange to have Enginemen adhere to paragraph 4, Page 29—C.T. 290.

Arrange to have engine crews instructed in connection with Special Instruction 1167-A22.

Arrange with enginemen to exercise particular care to avoid injuring men working on tracks during snowstorms.

Provide an adequate supply of engines for use on Patrol Trains, Wire Trains, and snow fighting equipment.

Arrange for diesel engines for shifting service at Sunnyside Yard when necessary.

Confer with Regional Engineer, Master Mechanic, Supvr. Train Movement and Freight Train Master on supply of engines and crews for snow fighting service and necessary replacements of engines for regular service.

Arrange for supervision at Sunnyside Yard Enginehouse, Meadows Enginehouse, Newark Station, Waverly Yard and Trenton Station.

On request of Supervisor Passenger Train Operation arrange for movement of B-1 locomotives to Enginehouse, Sunnyside Yard for coupling of the locomotives.

Arrange for additional locomotives required on account of coupling locomotives in Sunnyside Yard.

AREA STOREKEEPER:

Will:

See that sufficient supplies are available to take care of all requirements of the Region during snow and sleet storms.

Arrange to have a man assigned to his office sub-

ject to call from the Region and ready to assist in securing additional or emergency supplies as required.

AGENTS—STATION MASTERS:

Will:

Arrange to post appropriate signs to keep the public currently informed of train operations. Where public address systems are available announcements will be made currently informing the public of operational changes. Signs approved by the Passenger Manager will be kept available at all times.

Will arrange to keep train crews advised of operating conditions, assigning the necessary personnel to cover this job thoroughly and currently.

When weather conditions are such as may interfere with the normal movement of trains.

(a) When stations are open, secure authority from Superintendent Freight Stations & Superintendent Passenger Stations before stations are closed.

(b) When stations are closed, call Superintendent Freight Stations & Superintendent Passenger Stations Office for instructions.

If means of communication have failed and severity of the storm warrants, Agents will proceed to their station and put the Snow Removal and Emergency Programs into effect.

Arrange to keep waiting rooms open when train service is interrupted.

Communicate with Superintendent Freight Stations & Superintendent Passenger Stations Office in regard to any unusual situation, and take such action as is necessary when unable to do so.

PASSENGER MOVEMENT CLERK:

Will:

On request of Long Island Railroad arrange to have Master Mechanic apply extra pressure and supply additional fuses on contact shoes of electric locomotives and cars.

Notify Road Foreman of Engines and Master Mechanic of condition of wire requiring coupling of B-1 Engines in Sunnyside Yard.

Upon request of Supvr. Communication & Signals, arrange to have Multiple Unit cars equipped with pantographs having a minimum working height of 25 feet 11 inches, or AC Motor with P-70 type equipment, operated on Trains 2500 and 2509.

EQUIPMENT

Chloride cars are to be placed under heat as soon as snow or freezing rain starts.

They will be ordered into service by the Regional Engineer.

Contact trouble is to be expected under the following conditions:

- 1. When the third rail is subject to sleet or a freezing rain.
- 2. When snow is falling, not drifting, and has reached the base of third rail.
- 3. When snow is falling and there is sufficient wind to cause snow to drift against third rail.

When third rail contact trouble is expected, he will provide Chloride Car with force.

Multiple Unit Chloride Train:—W. A. Potter, Gang Foreman, Third Rail, Residence—114-54 223rd St., St. Albans, L. I. Day Call UPtown 2379, Night Call—Laurelton 5-2340, will have charge of the equipment of Chloride Car No. 497106 and the two MP-38 coaches located on No. 12 Track at Jersey City Passenger Station, and be responsible for their condition. The cars are to be ready for service at all times and sufficient chloride is to be provided for 48 hours constant use. When Third Rail contact trouble is expected he will provide Chloride Car with force.

Chloride Car No. 497106 is of proper dimensions to run on Station tracks at Journal Square and Station tracks at Harrison and Newark. This train must not go in the H.&M. Tunnel. Single track movement between Bridge No. 2.35 and "Waldo" must be made.

WHEN HURRICANE IS EXPECTED

When weather conditions indicate a hurricane that may interfere with normal movement of trains:

MOVEMENT DIRECTOR:

Will:

Notify Department Heads.

Receive all weather reports which will be furnished by Supervising Operator and advise proper staff members of any unusual conditions.

Check the location of wire trains to see that they are available for use.

DEPARTMENT HEADS:

To arrange for proper supervisory forces and equipment to be available as needed.

SUPERINTENDENT PASSENGER STATIONS:

Will see:

That an organization for disseminating information is provided for Pennsylvania Station, New York, Newark and Trenton, N. J.

That Agents secure information and prepare lists, showing names, addresses and telephone numbers of bus and taxicab companies in their territory that can be used in emergency.

That station facilities such as heating, lighting, etc. are in proper condition.

WHEN HURRICANE HAS ARRIVED

When hurricane has arrived and weather reports indicate the probability of sustained wind velocities in excess of 50 m.p.h.:

DEPARTMENT HEADS:

Confer with Regional Manager regarding the stopping of all train movements when extreme conditions warrant such action. For convenience of passengers, trains should be stopped at or near stations.

To immediately assign their forces to proper locations to the extent necessary.

Arrange to set up commissary facilities for hurricane forces.

MOVEMENT DIRECTOR:

Train Dispatchers to obtain information at the first sign of hurricane and promptly notify Movement Director who will notify the Regional Manager and Department Heads, and at night, Sub-Department heads as shown on page No. 23 as well as the Power Bureau at Philadelphia (phone Broad 666.)

Arrange for engines and crews for wire trains and work trains when requested by Regional Engineer.

REGIONAL ENGINEER:

Will:

See that an adequate force is placed on wire trains at Sunnyside, Newark and Trenton.

Arrange for electric traction man at Sunnyside, Pennsylvania Station—New York, Newark, New Brunswick and Trenton to inspect pantographs.

Confer with the Movement Director and arrange for operation of Wire Train and Work Trains when conditions warrant.

Set up portable air compressors and make necessary arrangements for connection to air lines at all interlockings now using commercial electric to operate air compressors.

Reduce speed of trains to 30 m.p.m. when wind velocity exceeds 50 m.p.h.

Set up portable electric generators in readiness for use as required.

Assist Superintendent Passenger Stations in setting up information center at Pennsylvania Station, New York, Newark and Trenton.

MASTER MECHANIC:

Will:

Assign a representative at Sunnyside Enginehouse to keep currently informed on all passenger road power and work directly with Road Foreman of Engines' representative in "40" office for power assignments. This person must be of caliber that he can give reasonable estimates of power that will be available for several hours in advance. The same coverage must be provided at South Amboy and Meadows.

Arrange to protect operation at Bay Head with P.R.R. personnel to insure proper handling of P.R.R. equipment at that terminal.

Set up sufficient force at New York Pennsylvania Station to carefully inspect pantographs of all westbound trains and

at Newark to carefully inspect pantographs of all eastbound trains.

See that sufficient force is available to prepare and turn engines without delayl.

Keep in touch with all terminals to see that all needed supplies are available.

Arrange to apply extra pressure on contact shoes and supply additional fuses on electric locomotives and cars.

Assist Superintendent Passenger Stations in setting up information Center at Pennsylvania Station, New York, Newark and Trenton.

See that sufficient forces are available to police tunnels and float bridges to check equipment involved on these facilities.

PASSENGER MANAGER:

Representative of Passenger Manager will locate in "40" Office, Room 258 (Ext. 2281). He shall keep clearly informed as to local transportation conditions, relaying the information obtained to office of Passenger Manager (Ext. 2056) so that it will be available to System Passenger Sales Department and other affected regions. He shall also furnish the Regional Transportation Department with such current information about regional static conditions as they may desire and information about conditions in other regions which may otherwise be unobtainable.

Passenger Manager's representative in "40" office shall keep Manager of Public Relations, Station Agents, Station Masters, Baggage Agents, the Superintendent Passenger Stations, and the Superintendent Freight Stations, furnished with such current information as is available in order that proper signs may be prepared, announcements made, bulletin boards kept currently correct as to conditions and fully informed as to probable delays and other unavoidable abnormalities of service and fully instructed as to what information they are to give passengers.

Station forces shall cooperate with the Transportation Department in relaying information to train crews vital to the success of keeping the public informed.

It will be the duty of the Passenger Manager or his representative to see that the P.U.C. of N. J. receives prompt notification of any troubles being experienced and the steps being taken to meet the emergency.

SUPERINTENDENT OF FREIGHT STATIONS:

Will:

Public will be kept currently advised of train departures and schedules by appropriate signs and announcements.

See that station forces are properly placed and prepared to meet any emergency situation that may develop.

SUPERINTENDENT PASSENGER STATIONS:

Will:

Public will be kept currently advised of train departures and schedules by appropriate signs and announcements.

See that station forces are properly placed and prepared to meet any emergency situation that may develop.

Set up information center at Pennsylvania Station, New York, Newark, and Trenton, for dissemination of information to patrons in the stations and give prepared memos to train crews for delivery to passengers, advising of probable delays while enroute at New York, Newark and Trenton.

SUPERVISORS OF TRACK:

Will:

Remain on their sub-divisions to see that forces are properly assigned.

Confer frequently with Regional Engineer as to conditions as well as force and equipment needed to keep the road open.

Supply necessary food to all men employed on their subdivision at as convenient a location as possible.

Confer with Regional Engineer and arrange for work trains when conditions warrant.

Set up portable air compressors at interlockings and make necessary arrangements for connection to air lines at all interlockings now using commercial electric to operate air compressors.

SUPERVISOR COMMUNICATION AND SIGNALS:

Will:

Confer with the Regional Engineer to insure that adequate emergency forces are available to maintain communication lines and the operation of interlocking signal systems and electric traction forces.

See that adequate force is placed on wire trains at Sunny-side, Newark and Trenton.

Arrange for electric traction man at Sunnyside, Pennsylvania Station New York, Newark, New Brunswick and Trenton platforms to inspect pantographs.

Confer with Regional Engineer and arrange for operation of wire trains and work trains when conditions warrant.

Confer with Train and Locomotive Dispatchers and arrange to have MU cars equipped with pantographs having a minimum working height of 25 ft. 11 inches or AC motor with P-70 type equipment operated on Train 2500 and 2509.

SUPERVISOR TRAIN MOVEMENT:

Will protect freight train movements as warranted by weather conditions, holding trains if necessary or yarding at first convenient terminal. Confer with officers of other departments in organizing operation so that work, wreck, wire and other trains will be properly crewed and powered.

SUPERVISING OPERATOR:

Will have general charge of road train movement, conferring with officers of transportation and other departments for a coordinated operation. Will assist in the arrangement for proper transmission of necessary information. Will see that tower personnel operate switches as infrequently as possible, cooperating with track forces.

PASSENGER TRAIN MASTER:

Will be in general charge of passenger train operation. Will assist Superintendent Passenger Stations in arranging for information centers at New York, Newark and Trenton, so that information can promptly and properly be transmitted to members of train crews who must keep the travelling public informed of delays and plans for further operation. Confer with Passenger Manager and System Superintendent Passenger Operation for a coordinated passenger service. Assist in the care and comfort of passengers who are extensively delayed, paying particular attention to heat and meals. Arrange for MU cars equipped with minimum pantograph working height of 25 feet 11 inches or AC motor or diesel with coach to operate Trains 2500 to 2509.

SUPERVISOR PASSENGER TRAIN OPERATION:

Will have general charge of New York and Sunnyside train movements, conferring with transportation and other officers in planning train movements.

FREIGHT TRAIN MASTER:

Will have general charge of all yard transportation activities. Will confer with transportation and other officers for a coordinated operation.

ROAD FOREMAN OF ENGINES:

Will:

Assign representative to handle all passenger power assignments and work directly with Enginehouse Foreman, Sunnyside, South Amboy and Meadows, The Power Coordinator, Philadelphia and Passenger Train Master in "40" Office.

Arrange to have engine crews instructed in connection with Special Instruction 1167 A-23. Set up for General Order on Special Instruction 1167 A-23.

Arrange with enginemen to exercise particular care to avoid injuring men working on tracks during hurricane.

Provide adequate supply of engines for use on wire train and work trains.

Arrange for diesel engines for shifting service at Sunny-side Yard, when necessary.

Confer with Regional Engineer, Master Mechanic and Freight Train Master on supply of engines and crews for hurricane service and necessary replacements of engines for regular service.

Arrange for Supervision at Sunnyside Enginehouse, Pennsylvania Station, New York, Newark Station and Trenton Station.

AREA STOREKEEPER:

Will:

See that sufficient supplies are available to take care of all requirements of the division during hurricane.

Arrange to have a man assigned to his office subject to call from the Regional Engineer and ready to assist in securing additional or emergency supplies as required.

AGENTS—STATION MASTERS

Will:

Arrange to post appropriate signs to keep the public currently informed of train operations. Where public address systems are available announcements will be made currently informing the public of operational changes. Signs approved by the Passenger Manager will be kept available at all times.

Will arrange to keep train crews advised of operating conditions, assigning the necessary personnel to cover this job thoroughly and currently.

When weather conditions are such as may interfere with the normal movement of trains:

Call Superintendent Passenger Stations and Superintendent Freight Stations as to whether station should remain open or whether the station should be closed, whatever the case may be.

Arrange to keep waiting rooms open when train service is interrupted.

Communicate with Superintendent Passenger Stations and Superintendent Freight Stations Office in regard to taking such action as is necessary when unable to do so.

If means of communication have failed and severity of storm warrants, Agents will proceed to their station and put emergency program in effect.

PASSENGER MOVEMENT CLERKS:

Upon request of Supvr. Communication and Signals, arrange to have MU cars equipped with pantographs having a minimum working height of 25'-11" or A.C. motor with P-70 equipment operated on Trains 2500 and 2509.

MANAGER PUBLIC RELATIONS

Will keep currently posted on all movements affecting the public through the Passenger Manager's representative in "40" office. Will disseminate information to the public after such has been screened by Regional Manager's designated representative. Emphasis will be on what we are doing rather than on delays and annulments.
